You acknowledge and accept that, should the Project fail to conform to the general readability standards, we have the right to request an immediate revision of the Project, deny pending payments, and/or cancel this Agreement.

If we deem the Project as inappropriate at any time, either upon submission or

We may also refuse to use any portions of the Project in any publication related or unrelated to Dr.Fone.
